PURCHASE AGREEMENT

This agreement was entered in to on -----, between the parties, Paul Bainbridge, also known as Apollodane Great Danes (seller) and,

The purpose of this agreement is to outline and define the cost, delivery, guarantee, and / or spay/neuter concerning the purchaser of a Great Dane puppy from Apollodane Great Danes.

- 1) Buyers deposit of, for the purpose of purchasing a puppies is non refundable if buyer fails to complete transaction.
- 2) Buyers unpaid balance of, will be paid in full before Buyers choice of puppy is removed from the litter, unless prior payment arrangements have been made between the buyer and the seller.
- 3) Buyer acknowledges that the above purchase price is for a puppy only. Buyer further agrees that any additional costs related to the shipping, crate, health certificate, veterinarian fees, kennel fees and all shipping, air or other transport methods which may be required after the said purchase to the point of final destination must be paid in advance by buyer. If prior arrangements have been made between seller & buyer regarding the puppy staying with Apollodane Great Danes longer than 8 weeks, buyer is responsible for any vet charges accrued during puppies stay until delivery to buyer, deposit money will be applied to veterinarian bill and balance owed will be adjusted.
- 4) All deposit and purchase monies shall be refunded if seller fails to complete transaction and deliver puppy to buyer.
- 5) Buyer will take puppy to veterinarian of their choice for a health assessment within two weeks of ownership and produce a record of assessment, veterinarian name and phone number to Apollodane Great Danes on e-mail men444@spidernet.com.cy or fax (00357) 26652008. This assessment will include baseline bloodwork, urinalysis and stool check. Buyer gives seller authorisation to speak with family veterinarian at any time regarding any health issues with puppy / dog / bitch purchased from Apollodane Great Danes.
- 6) Sellers puppy guarantee covers Artial Septal / Interventricular Septal Defects, Persistent Ductus Arteriosus, Persistent Right Aortic Arch, Pulmonic Stenosis, Aortic Stenosis, Tetralogy, of fallot, Stockards Disease, MegaEsophagus, Renal Dysplasia, Unilateral Renal Agenesis, Polycystic Kidneys, Ectopic Ureter, Ehlers-Danlos Syndrome, Cyclic Neutropenia, Cheiloschisis, Palatoschisis, Atresia, Rectovaginal Fistula, Dyschondroplasia and Spina

Bifida. All the named must be diagnosed by the age of one year determined by the birth of the pup and prevent the animal from leading a healthy and active life following corrective surgery performed through surgery / and or / medications, and providing that all the above mentioned are not caused by abuse, and/or neglect, and/or lack of care on the part of the buyer. A written veterinarian diagnosis must be obtained and a necropsy must be performed at buyers expense and submitted to seller as proof of any of the above said disease or defect before the animal reaches one year of age. Seller must be notified in writing of disease or defect before any action can be taken by the buyer. Hip Dysplasia is covered for the life of the dog. Hip Dysplasia must be scored Mild, Moderate or Severe with veterinarian and must prevent the animal from leading a healthy life after corrective actions are performed through surgery and / or medical treatment. Veterinarian results must be submitted to seller as proof of said defect at any age. A written veterinarian statement must accompany results. Films must also be reviewed by sellers veterinarian. Seller will not cover acquired diseases, illness, and / or defect.

- 7) This guarantee entitles the buyer to a puppy of equal value from future litters. If any of the above maladies occur. Puppy selection will be determined by Apollodane Great Danes. Coloration may not be the same as the original puppy. Buyer must pay transportation, shipping, air freight or road plus any health certificates or documentation to acquire a replacement puppy. If puppy purchased was on any kind of payment plan then any monies already paid may be applied towards new puppy.
- 8) Seller guarantees each puppy is in fact pedigree, and unless financed, will provide a valid registration card to buyer when it becomes available. Seller will also provide a full and detailed pedigree on both the Sire & Dam. Both parties acknowledge that the said puppy will be used only for the purpose of, Showing..... Breeding.....Pet..... and that the animal will be neutered and /or spayed with proof of said spay or neuter to be sent to Apollodane Great Danes by six months of age unless prior arrangements have been made between seller and buyer
SIGN BOTH PARTIES.....
- 9) This contract becomes null and void and the buyer is not entitled to any refund in the event buyer fails to provide seller with records identified in five (5) of this contract, the puppy has been bred, abused, and / or neglected medically or physically, put to sleep, returned sick and / or dying, except from disease listed in item six (6) or Kennel Club Registration has expired. This guarantee applies to the original buyer and is reserved for Apollodane Great Danes to transfer.
- 10) In the event the buyer does not want the puppy dog for any reason, the buyer must return puppy/dog to Apollodane Great Danes. Up to seven (7) days after the date of this contract Apollodane Great Danes will reimburse fifty (50)% of purchase price to the buyer. From seven (7) days up to fourteen (14) days from the date of this contract Apollodane Great Danes will reimburse buyer twenty (20)% of purchase price to buyer. Apollodane Great Danes will not reimburse any money to the buyer for puppy/ dog being returned after fourteen (14) days from this contract date. Apollodane Great Danes will not reimburse any money to the buyer at any time from the date of this contract if puppy / dog has been returned abused, neglected, sick or dying except for any diseases listed in section 6, has been put to sleep without agreement from Apollodane Great Danes, stolen, lost, impounded or without the correct form of tag and

registration documents. The buyer will transfer ownership to Apollodane Great Danes in the event puppy / dog has already been registered by the buyer.

- 11) Any transportation, health certificates, and / or shipping crate costs involved in returning the puppy / dog to Apollodane Great Danes will be the buyer's responsibility.
- 12) Both parties recognise Paphos in Cyprus is the place that this agreement was entered in to and it acknowledges that Paphos Court is the court of jurisdiction should any dispute arise from this agreement.
- 13) If buyer breaches this contract then the buyer is said to be in default. If buyer defaults on this contract then the buyer agrees to return said puppy / og without any reimbursement and pay an additional £cyp500.00 (five hundred) plus all court costs, fees, and any costs incurred by seller in obtaining puppy plus Solicitor fees not exceeding twenty (20)% of total judgement against buyer.
